The Iowa Engineering and Land Surveying Examining Board (Board), and Dennis J. Snyder (Respondent) enter into this Consent Order (Order), pursuant to Iowa Code section 17A.10 (2009) and 193 Iowa Administrative Code 7.42:

1. The Board has jurisdiction of this matter pursuant to Iowa Code chapters 17A, 272C, and 542B (2007, 2009).
2. Respondent was issued Iowa license number 08903 on the 3rd day of November, 1978. His license is active and will next expire on December 31, 2009.
3. Respondent and the Board entered into a Combined Statement of Charges and Consent Order on November 7, 2007, as a result of Respondent's practice on an expired license between January 1, 2006 and September 5, 2007. Respondent was ordered to pay a civil penalty of \$1,000 (which he paid) and was required to complete the 40 PDH correspondence course offered by the Murdough Center for Engineering Professionalism, College of Engineering, Texas Tech University, providing a certificate of completion by July 1, 2008.
4. The Board charged Respondent with failure to comply with an order imposing discipline when he failed to submit proof of completion of the required course on engineering professionalism. Respondent has now supplied proof that he ordered the course in February 2008, although he didn't complete the course until January 30, 2009.
5. Respondent admits he failed to comply with the Board's Consent Order. He has assured the Board he will be responsive in the future and comply with all Board rules and laws.
6. Respondent and the Board have agreed to resolve this case. Respondent has a right to a hearing on the charges, but waives his right to hearing and all attendant rights by freely and voluntarily entering into this Order. This Consent Order is the final agency order in a disciplinary contested case.
7. This Order shall be part of the permanent record of Respondent and shall be considered by the Board in determining the nature and severity of any disciplinary action to be imposed in the event of any future violations.
8. This Order and the Notice of Hearing and Statement of Charges are public records available for inspection and copying in accordance with the requirements of Iowa Code chapter 22 (2009).

9. Failure to comply with the provisions of this Order shall be grounds for disciplinary action pursuant to Iowa Code section 272C.3(2)(a) (2009). However, no action may be taken against Respondent for violations of these provisions without a hearing, or waiver of hearing.

10. This Order is subject to approval of the Board:

(a) If the Board fails to approve this Order, it shall be of no force or effect on any party, and it shall not be admissible for any purpose in further proceedings in this matter.

(b) If the Board approves this Order, it shall fully dispose of all issues in this case.

IT IS THEREFORE ORDERED:

A. Reprimand


Respondent is reprimanded for failing to comply with an order imposing discipline.


