

STIPULATION AND AGREEMENT

This Stipulation and Agreement ("Stipulation") entered into by and between Gary A. Hintermeister ("Mr. Hintermeister") and the Iowa Architectural Examining Board ("Board") state:

1. On or about November 19, 1990, Mr. Hintermeister filed an application for reciprocal registration as an architect in the State of Iowa. Mr. Hintermeister is a registered architect in good standing in Wisconsin and Illinois.

2. On or about December 13, 1990, the Board issued Mr. Hintermeister Iowa registration number 3092.

3. The Board issued Iowa registration number 3092 in error as Mr. Hintermeister's application for registration was not approved by at least four members of the Board as required by Iowa Code § 118.9.

4. The Board could not have approved Mr. Hintermeister's application for reciprocal registration as he lacks the requisite education for registration as set forth in Iowa Code § 118.8 and 193B I.A.C. § 2.1(1) and § 2.2.

5. But for the Board's error, Mr. Hintermeister would not have been issued an Iowa registration.

6. The Board has requested Mr. Hintermeister voluntarily surrender his Iowa registration for the sole reason that the registration was issued in error and Mr. Hintermeister lacks the requisite education for registration.

7. In light of the foregoing, Mr. Hintermeister voluntarily surrenders Iowa registration number 3092 and the Board hereby accepts the voluntary surrender of Iowa registration

number 3092, effective the date this Stipulation is signed by all parties.

8. There are none and have not been any complaints or disciplinary proceedings against Mr. Hintermeister. Nothing in this Stipulation shall be construed to suggest that Iowa registration number 3092 has been surrendered to settle a complaint or disciplinary proceeding against him.

9. Mr. Hintermeister's voluntary surrender of Iowa registration number 3092 shall not impair his ability to seek registration as an architect in the State of Iowa once he has satisfied the requirements for registration.

10. Nothing in this Stipulation shall be construed as requiring the Board to approve any application for registration submitted by Mr. Hintermeister. Any application submitted by Mr. Hintermeister shall be reviewed to determine whether the necessary requirements for registration have been satisfied.

11. A copy of this Stipulation shall be placed in Mr. Hintermeister's file. The Stipulation is a public record pursuant to Iowa Code chapter 22 and available to any person on request under the terms of that chapter. Notice of surrender of this registration shall not be sent to NCARB, any state licensing board or agency, or any national disciplinary information service unless accompanied by a copy of this Stipulation. Mr. Hintermeister's surrender of his Iowa registration shall not be published in the newsletter of the Iowa License Examining Board. Nothing in this Stipulation shall be construed to prevent the

Board from providing a copy of this Stipulation to any person upon request under the terms to chapter 22 of the Iowa Code.

12. Mr. Hintermeister agrees to provide the Board with a list of all architectural documents sealed using Iowa registration number 3092 within ten (10) business days after this Stipulation is signed by all parties. Mr. Hintermeister further agrees to give the Board or its designees the opportunity to inspect and copy, at the Board's expense, any architectural documents sealed with Iowa registration number 3092, and supporting documents thereto.

13. Iowa registration number 3092 was issued and in effect from the date of its issuance through the date this Stipulation is signed by all parties.
