CEASE AND DESIST ORDER  
BY STIPULATION

The Iowa Architectural Examining Board ("Board") and Dennis A. White d/b/a/ Dennis A. White Architectural Designer ("White") stipulate to the following Cease and Desist Order pursuant to Iowa Code § 544A.15 (1999):

1. White is an individual residing in Charles City, Iowa.
2. White is not a registered architect under Iowa Code chapter 544A(1997). White is not a registered engineer under Iowa Code chapter 542C(1997).
3. The Board is authorized by Iowa Code section 544A.20 to seek an injunction in district court enjoining any person who is not legally authorized to practice architecture in Iowa from engaging in such practice or offering to engage in such practice. Iowa section 544A.15 also authorizes the Board to impose civil penalties for the same violations. Pursuant to Iowa Code section 544A.1, only persons qualified under the laws of the state of Iowa are authorized to practice architecture in Iowa.
4. The Board and White have agreed to informally resolve a pending complaint concerning White's advertising in the June 1999/2000 U.S. West Dex

**yellow pages. The advertising lists "Dennis A. White, Architectural Designer" under the section titled "Architects".**

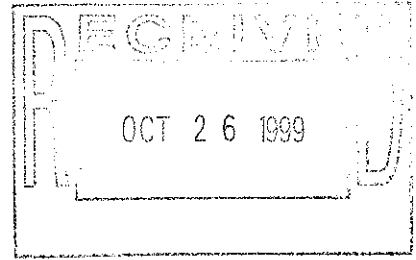
**5. In the event this Stipulation is violated, it may be used as evidence in a subsequent enforcement action before the Board or in district court.**

**6. White agrees that he will not in the future engage in the practice of architecture in Iowa, as defined in Iowa Code section 544A.16(9), or represent to the public any ability or authority to do so without becoming registered as an architect in Iowa.**

**7. While White agrees to become registered or refrain from engaging the practice of architecture in Iowa, White recognizes his current yellow pages advertising will be in circulation for some time offering architectural design services. Some Iowans may contact White for design services believing he is a registered architect in Iowa. White therefore agrees that he will provide a written disclosure to all Iowa clients informing them that he is not registered as an architect in Iowa until his current yellow pages advertising is out of circulation or he becomes registered in Iowa, whichever first occurs.**

**8. This Stipulation is a public record pursuant to Iowa Code chapter 22.**
