AQB Exposure Draft of Proposed Revision to the 2015 Real Property Appraiser Qualifications Criteria, Guide Note 9

Griebel led a discussion of the draft proposal. Iowa statute authorizes/mandates an FBI finger-printed criminal history background check only when required by the Appraiser Qualifications Board (AQB). In the revised draft, there is no longer a requirement and instead a generic statement that appears to be more of a suggestion not a requirement. This may be problematic. Griebel also cited previous concerns with the limitations placed on states due to any criminal history in an applicant's background. There would appear to now be no clear direction and leaves the interpretation very loose, which appears to serve no purpose in obtaining a background check.

It also appears that either the guide note or the draft proposal has a typo. There is a missing "C" in the new standard, but a cross-reference remaining to section "C" in Guide Note 9.

Griebel told the Board that their ability to perform criminal background checks hinges on whether the AQB feels an FBI criminal history check is needed to comply with the standards it develops. Iowa's 543D.22 allows the board to require a national criminal history check through the federal bureau of investigation only if needed to comply with federal law or regulation, or the policies of the appraisal qualification board of the appraisal foundation.

Schoenewe asked for clarification on the implications of paragraph B(i) on page 7 of the draft document and the missing section C on page 6.

Motion by Nelsen to direct Bright to create a response letter to the AQB from the Iowa Board regarding the draft of proposed revision to the criteria and Guide Note 9.
