- 36. William E. Hegstrom admits that by failing to provide Individual Ledgers for the properties listed in paragraph 45 of the Complaint, he violated 193E Iowa Administrative Code Section 1.27(117).
- 37. William E. Hegstrom has a right to a hearing on this matter but waives his right to a hearing.
- 38. William E. Hegstrom does hereby voluntarily submit his Iowa Real Estate License (B01128) for immediate revocation.
- 39. William E. Hegstrom understands that Iowa law allows him to re-apply for an Iowa Real Estate License if revocation took place two years (or longer) prior to re-application.
- 40. William E. Hegstrom understands that re-application for an Iowa Real Estate License may or may not be granted by the Iowa Real Estate Commission and that the violations of law admitted herein may provide a basis for denial.
