LEGISLATION/RULES COMMITTEE

Rules Committee Reconvene

Vogt advised that the Rules Committee will meet this afternoon to look at the next wave of rule changes to consider. Vogt stated that summaries will be distributed to the board members and to contact one of the committee members if there are any concerns.

NEW BUSINESS

Discuss Ashton's Reinstatement

Lampe advised that Ashton has applied for reinstatement of his license and has been charged with providing false statements while serving in the military. The Board discussed and agreed to allow him to apply to reinstate his license.

MOTION by Folkerts second by Fairfax to approve reinstatement for Ashton providing he meets the requirements for reinstatement. Motion carried unanimously.

Vote on 2021 Zone Meeting – Iowa

Vogt advised that the Iowa Board would have a lead person to work with NCEES on the 2021 Zone meeting in Iowa. Vogt stated the meeting would most likely be held in Des Moines. Vogt advised that NCEES does a lot of the work involved, and there is no financial commitment required from the board.

MOTION by Folkerts second by Herold to approve the 2021 Zone Meeting in Iowa. Motion carried unanimously.

NCEES Update - Vogt

Vogt advised that the new headquarters building is moving quickly toward something in Greenville. Vogt stated that NCEES has donated \$3 million over three years to engineers without borders, and there has not really been any updates on this. Vogt advised that NCEES is making a financial commitment to outreach and zone funding change for the Engineering Change Lab. Vogt stated that the Examination Policy and Practices Committee will recommend there is no need to have a Group 1 and Group 2 for exams. Vogt said there have been no exam volume issues and there was discussion on how to reinstate dropped exams. Vogt advised that two MBAs changed within the zone due to retirement and a new governor. Vogt stated he has set up a special committee on Outreach and Comity to get zones together to talk about mobility and what different boards are doing within the zone. Vogt advised at the joint zone meeting Jerry Shellberg was nominated for the distinguished service award but there were no other nominations.

Discuss Edits to PLS Reference Forms

Herold and Folkerts stated that the specific questions on the Land Surveying Reference form are necessary and need to stay on the form. Lampe advised that he will put a hold on changes to the PLS reference forms until changes in the code are approved.

Vote on Attendees – NCEES Annual Meeting – August 14-17, Washington, D.C. MOTION by Folkerts second by Herold to approve Lampe and all board members to attend the NCEES Annual Meeting in Washington D.C. pending approval from management. Motion carried unanimously.

Vote on Chair (VanDenBerg), Vice-Chair (Folkerts) 2019-2020. MOTION by Fairfax second by Perea to approve VanDenBerg as Chair and Folkerts at Vice Chair for 2019-2020. Motion carried unanimously.

Lampe presented the Committee's recommendations on the following cases:

18-04 Recommend continue to monitor. On hold pending outcome of other cases.

18-10 Recommend to close. Documentation of PDH provided within 60 days.

18-12 Waiting on more information. Lampe advised that Longman was trying to acquire better evidence. Lampe will send letters to each of the complainants in the open cases requesting more information. Lampe will send a letter to Dale Eschliman advising of suspicion that his seal is being used by someone else. Lampe will send a certified letter to Kirk Eschliman advising that the cases are being reviewed and asking his involvement. Dawson advised he can submit a FOIA request to FEMA to see if Eschliman's stamp was used on any documents.

19-01 Recommend to find probable cause. Self-reported discipline. Lampe advised that respondent was charged with embezzlement from three organizations that were not work related, and two counts were dismissed. Lampe advised that respondent is on probation for three years and has voluntarily placed his South Dakota license on suspension for three years. The board discussed not allowing him to be able to automatically renew his license and requiring 8 hours of ethics.
