- 1. Following its receipt of a "Certificate of Noncompliance" from the lowa

YOU ARE HEREBY NOTIFIED, PURSUANT TO IOWA CODE SECTIONS 272D.7 AND 272D.8, THAT:

- 1. The Iowa Real Estate Commission ("Commission") intends to suspend your **ACTIVE** real estate license ("license") due to the Commission's receipt of the attached certificate of noncompliance from the Iowa Department of Revenue, Centralized Collection Unit ("Unit").
- 2. You must contact the Unit at the address or phone number in the attached certificate to schedule a conference or otherwise obtain a withdrawal of the certificate of noncompliance.
- 3. Unless the Unit furnishes a withdrawal of the certificate(s) of noncompliance to the Commission before October 8, 2019, your **ACTIVE** license with the Commission will be suspended.
