Now on this 15th day of December 2020, the Iowa Real Estate Commission [Commission] makes the following findings:

- 1. Following its receipt of a "Certificate of Noncompliance" from the Iowa

 Department of Revenue issued pursuant to Iowa Code section 272D.7, the Commission served

 upon the Respondent a "Notice of Intent to Suspend License" [Notice] on October 12, 2020.
- 2. The above-referenced Notice provided that the Respondent's real estate salesperson license would be suspended if the Commission did not receive a "Withdrawal of the Certificate of Noncompliance" from the Iowa Department of Revenue within 60 days.
- 3. As of the date of this Order, the Commission has not received a withdrawal of the certificate of noncompliance; nor has the Commission received a court order or other evidence that the Respondent timely filed a judicial review action under Iowa Code section 272D.9 challenging the suspension of her license.
- 4. Because more than 60 days has elapsed since service of the above-referenced Notice was made upon the Respondent, the Commission is accordingly required to suspend the Respondent's license.

IT IS THEREFORE ORDERED that Respondent's license as a real estate salesperson is SUSPENDED until the Commission receives a notice of withdrawal of the certificate of noncompliance from the lowa Department of Human Services.

YOU ARE HEREBY NOTIFIED, PURSUANT TO IOWA CODE SECTIONS 272D.7 AND 272D.8, THAT:

- 1. The Iowa Real Estate Commission ("Commission") intends to suspend your **ACTIVE** real estate license ("license") due to the Commission's receipt of the attached certificate of noncompliance from the Iowa Department of Revenue, Centralized Collection Unit ("Unit").
- 2. You must contact the Unit at the address or phone number in the attached certificate to schedule a conference or otherwise obtain a withdrawal of the certificate of noncompliance.
- 3. Unless the Unit furnishes a withdrawal of the certificate(s) of noncompliance to the Commission before December 14, 2020, your **ACTIVE** license with the Commission will be suspended.
- 4. Pursuant to 193 IAC 8.3(2), the effective date of the denial of the issuance or renewal of a license, as specified in the notice required by Iowa Code section 272D.8, shall be 60 days following service of the notice upon the licensee or applicant.
- 5. Pursuant to 193 IAC 8.3(4) you are required to keep the Commission informed of all court actions and all actions taken by the Unit by providing copies to the Commission within seven days of filing or issuance, of all applications filed with the district court pursuant to Iowa Code section 272D.9, all court orders entered in such actions, and withdrawals of certificates of noncompliance by the Unit.
- 6. You do not have a right to hearing before the Commission, but you do have the right to contest this Notice by requesting a court hearing pursuant to Iowa Code section 272D.9, within thirty days of service of this Notice.
