Public Comment

Blake introduced himself as the new legal counsel for IAR and gave a brief summary of his work history and background.

Clingman went to Drake and later University of Iowa and has a degree in psychology. He is married with 5 children. Clingman summarized his work history which began in retail, followed by acting and singing in Hollywood, pharmaceutical work, and then settled at the post office for 20 years. He and his wife later moved to Ottumwa to be closer to his parents and in an effort to support them better, Clingman pursued his real estate license. Clingman shared that he was so inspired when he began his career in real estate and to this day still works for the same company, alongside his wife; who also works as a broker there.

Goddard presented a personal profile to the commission and to staff. She has worked for the State of lowa for 30 years; half of that has been for the PLB. Goddard shared her love for PLB management, the real estate team, and the Real Estate Commission members. Goddard expressed she is always learning something different and new. Goddard graduated from DMACC with an Associate Science degree,

obtained her real estate license in 2002, and obtained her CPM Certification through Drake. Goddard and her husband have one daughter and one son and have been married for 20 years.




