INFORMATION ON CBD USAGE IN IOWA

Owen Parker, Chief, Bureau of Medical Cannabidiol presented information on CBD usage in Iowa. He clarified the definition of medical cannabidiol, what patients and caregivers need to apply for CBD and when patients can have their products on them. Mr. Parker also discussed HF 2589 and what changes it made to legislation. He also provided statistics of usage by age, gender, and dispensary sales data.

EXECUTIVE DIRECTOR REPORT

Director Weinberg provided an update on the Governor's Emergency Proclamation. The newly extended proclamation has removed several of the emergency licensure provisions that were in place during the pandemic. As part of these changes, the Board will no longer be issuing emergency licenses and have notified all applicants and nursing programs of this change. Background checks will now be required again which means that fingerprints and waiver forms will need to be submitted prior to a license being issued. The NCLEX time frame has also returned to 91 days again. Director Weinberg advised that she is anticipating further changes when the next proclamation comes around.

The return to work plan for Board staff was also discussed. The Board is currently following the lead of Director Garcia. Once the return to work plan is set in place, the Board will start discussion on opening up to the public again and returning to in person meetings.

PROPOSE NOTICE OF INTENDED ACTION TO AMEND 655 IAC CHAPTER 6, NURSING PRACTICE FOR REGISTERED NURSES/LICENSED PRACTICAL NURSES

On a motion by Nancy Kramer, seconded by Amy Beltz, the Board moved to file under Notice of Intended Action to amend 655 IAC, Chapter 6, Nursing Practice for Registered Nurses/Licensed Practical Nurses, which exempts opioid treatment medication units from the proximate-area requirement for LPNs, provided that an RN assess the LPN's competency and is available for consultation at all times.

ENFORCEMENT

The Board discussed Endorsement Applicant 21-198, Felicia Velazquez. The Board did not take any formal action, deciding instead to offer a consent agreement.

The Board discussed Examination Applicant 21-197, Kevin Le. The Board noted that Mr. Le pled guilty to assault on his former partner, but under HF2627, the underlying conduct giving rise to the conviction did not directly relate to the practice of nursing as defined in Iowa Code chapter 272C. On a motion by BJ Hoffman, seconded by Gordon Goettsch, the Board voted to approve the Examination Application.
