SchraderBachar went into a discussion about an upcoming realignment of state agencies. PLB will be breaking away from the Department of Commerce, Division of Banking and will move to a new Department of Inspections, Appeals, and Licensing (DIAL) under a proposed bill, which will go into effect on July 1, 2023. PLB will be moving if the legislation passes. No date or location has been given for the move. Day-to-day operations from the board's point of view will be minimal. SchraderBachar reviewed the Governor's Executive Order 10, which is a moratorium on rule writing and a red tape review.

Lundquist added to the conversation that the Governor's office communicated they do not anticipate any layoffs or reduction in services. Ultimately, the DIA will oversee many licensing agencies through this streamline process with the intent to become more responsive to the public and be organized in a more rational and productive manner.
