

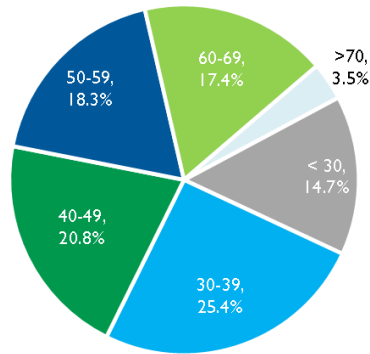

## Age Range of Active In-State Nurses

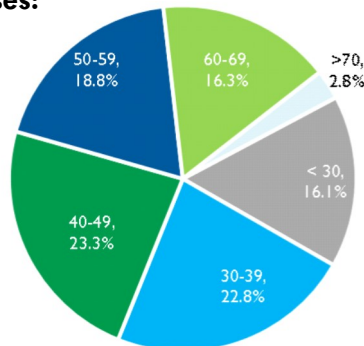


### Registered Nurses:

The mission of the board is to protect the public health, safety and welfare by regulating the licensure of nurses, the practice of nurses, nursing education and continuing education.

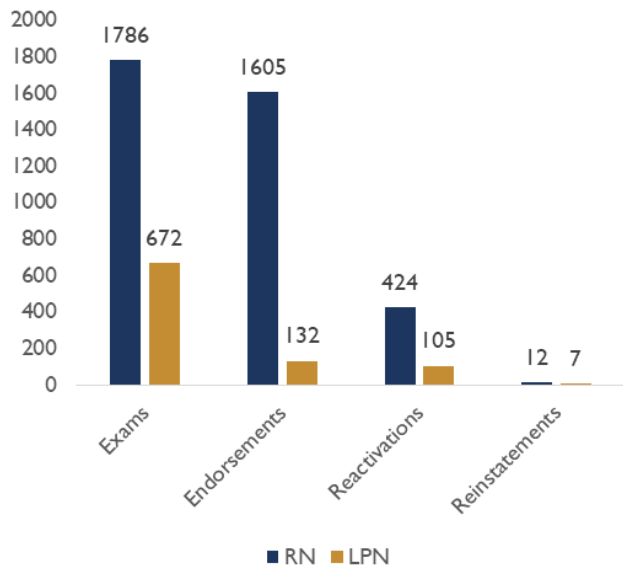
## Licensing Fees

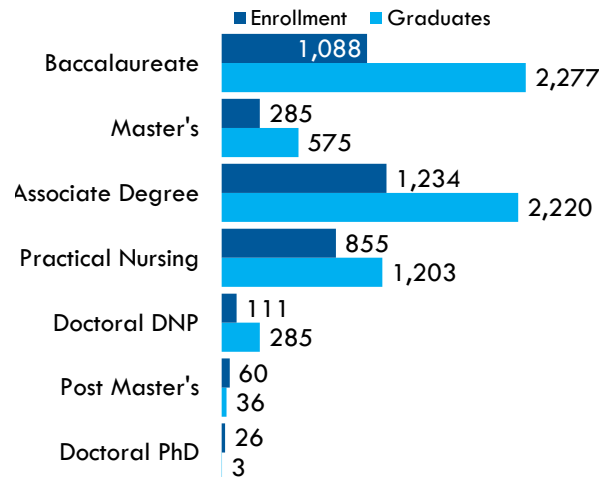
