## Administrative Rules Update - Joseph Fraioli, Legal Director

<u>Eligibility for Licensure - HF 2627</u>. The Rules were approved by the Board on 10.23.2020, and he is waiting for the other Boards to complete approval process so that the rules can be filed simultaneously, pursuant to a request by the Legislative Services Agency.

<u>Waiver Rule Revisions</u> - Notice of Intended Action was filed 12.3.2020 and a public hearing is set for 1.20.2021 at 1:00 p.m.

<u>Supervision of Executive Director</u> - Notice of Intended Action was filed 12.3.2020 and a public hearing is set for 1.20.2021 at 2:00 p.m.

## Judicial Review - Anagha Dixit, Assistant Attorney General

<u>Calcaterra v. Board of Medicine</u>-Domenico Calcaterra, M.D. The Board issued a declaratory order finding that statements of charges are public documents. Dr. Calcaterra renewed his petition for judicial review of this declaratory order. Parties briefed the matter and had oral arguments on the matter on January 17, 2020. This case received a decision on April 26, 2020. We have requested this decision be stayed and reconsidered. The Court heard oral arguments on the motions in July. The Court denied those motions in November. We have filed a notice of appeal and out brief is due in December.

Robinson v. Board of Medicine - David Robinson, M.D., entered a settlement agreement with the Board in 2016. In 2019, the Board terminated the terms of his probation. Dr. Robinson requested that the Board rescind the 2016 settlement agreement, and the Board declined to do so. Dr. Robinson has now sought judicial review of this agency action in district court. The appendix in this case was filed but Dr. Robinson alleges that the entire investigatory report should be part of the record. The Board has resisted the matter and a hearing was held on the issue on January 28, 2020. The matter has been submitted and awaiting an order.

<u>Yates v. Board of Medicine</u> - Leroy L. Yates, JR, M.D., lost a contested case on December 12, 2019. Dr. Yates filed a pro se Petition for Judicial Review, which the court ruled as timely. He has since acquired local Florida counsel. The parties both briefed the issues and an oral argument was held in District Court. The Board's decision was affirmed. As of the date of writing this summary, Dr. Yates has not filed a notice of appeal of that decision.

<u>Doe v. Board of Medicine</u> - John Doe, M.D., lost a contested case on January 16, 2020. The Petitioner had been ordered by the Board to attend a confidential comprehensive competency evaluation. A hearing was held on the matter over two days in 2019 and Administrative Law Judge Johnathan Gallagher issued his decision on January 16, 2020. A timely petition for judicial review was filed. The parties briefed the issue and had oral arguments. The Board's decision was affirmed and Dr. Doe has filed a notice of appeal. The parties will now need to re-brief for the appellate courts.

<u>Interstate Medical Licensure Compact</u> – Updates were given by Mary Jo Romanco and Dr. Warren Gall. They spoke about the annual Compact meeting and stated that Jaime Dunbar, licensure specialist for the Board, was a main presenter. They said that a new director will be appointed to the Compact in January of 2021.

The Board discussed and approved sending the drafted letter to the Governor, requesting that she fill the several vacancies for Board members and alternatives.

Dennis Tibben from the Iowa Medical Society updated the Board on the COVID 19 vaccination rollout efforts. He said that the state Infectious Disease Advisory Council (IDAC) continues to prioritize distribution, and that the Pfizer vaccine may be available as early as Sunday, December 13, 2020. He stated that IDAC hopes to see administration of the vaccine begin a week to ten days after receiving it.
