- 1. Proposed for adoption and filing to amend Chapter 10, "Controlled Substances," to temporarily add five substances to Schedule I of the Controlled Substances Act in response to similar action taken by the federal DEA.
- 2. Proposed for Notice of Intended Action to amend Chapter 10, "Controlled Substances," to temporarily add nine substances to Schedule I and one FDA-approved substance to Schedule IV of the Controlled Substances Act in response to similar action taken by the federal DEA.
