The “Enhanced” Nurse Licensure Compact – Moving Forward

On Friday, April 21, 2017, The Honorable Governor Terry Branstad signed SF419 into law. This bill is the “enhanced” language for the Nurse Licensure Compact (eNLC).

Before we move forward with what the eNLC means for Iowa nurses, let’s review where we are today. Iowa has been a member of the Nurse Licensure Compact for 16 years and this has given the nurses of Iowa the opportunity to practice in multiple states with one license.

The Nurse Licensure Compact (NLC) is an interstate compact. It allows a nurse to have one multistate license in their primary state of residency. This permits the nurse to practice in other member states both physically and electronically subject to each state’s practice laws.

To think of this in simple terms, the NLC is modeled after the driver’s license compact. Each of us are allowed to drive in another state with a license from the state we reside in, though we follow the rules and regulations of the state we are traveling in.

Moving forward with the eNLC, nurses will continue to have the ability to practice in multiple states with one license. The eNLC will also provide the following benefits:

1. The compact reduces regulatory requirements by removing the necessity for obtaining a license in each state.
2. The compact clarifies a nurse’s authority to practice in multiple states via telehealth, which in turn increases patient access to care and provides continuity of care.
3. The compact provides, in the rare event of any disciplinary issues, swift action taken by the Board of Nursing regardless of the state where the nurse is licensed or practices. If a nurse is disciplined, the information is placed into the national database, NURSYS®
4. The compact has uniform licensure requirements so that all states can be confident the nurses practicing with the eNLC have met a set of minimum requirements, regardless of the home state in which they are licensed.

The following are the uniform licensure requirements that a nurse must meet to be issued a multistate license, regardless of their home state:

- Meet the home state’s qualifications.
- Graduate from a qualifying education program.
- Passed the NCLEX-RN® or NCLEX-PN® exam (or predecessor exam).
- Have no active discipline on a license.
- Submit to a criminal background check and have no prior state or federal felony convictions.
- Not be currently enrolled in an alternative program.
- Have a valid U.S. Social Security number.

I would imagine that nurses presently holding a multistate license are asking themselves how the uniform licensing requirements of the eNLC will affect their licensure.

The Enhanced NLC (eNLC) has a grandfathering clause to address this question. A nurse holding a home state multistate license on the “Enhanced” compact’s effective date may retain and renew the license provided that:

- A nurse who changes primary state of residence after the eNLC’s effective date must meet requirements to obtain a multistate license from a new home state.
Example – Nurse Nancy holds a multistate license in Iowa, her primary state of residence. She moves to Missouri, also a compact state, but she has a history of a felony which would now prohibit her from receiving a multistate license in Missouri. Nurse Nancy may receive a single state license in Missouri if she meets the laws and rules set forth in Missouri for licensure.
- A nurse who fails to satisfy the requirements due to a disqualifying event occurring after the compact’s effective date is ineligible to retain or renew a *multistate* license.
Example – Nurse John holds a multistate license in Iowa, his primary state of residence. The Iowa Board of Nursing is informed that Nurse John has been convicted of a felony – he would no longer be eligible for a multistate license. He may, however, be eligible for a single state license in Iowa if he meets the laws and rules set forth in Iowa for licensure.

Another important matter is when the adopted eNLC will go into effect. The effective date of the eNLC legislation is determined by either 26 states joining the compact or by the date December 31, 2018.

- Example 1: If 26 states join by January 1, 2018, the eNLC becomes effective.
- Example 2: If only 20 states have joined by December 31, 2018, the eNLC still becomes effective.

As of this publication, 21 states have adopted the eNLC, therefore the number 26 is in reach.

In conclusion, it is important that all nurses in Iowa keep informed concerning the movement of the eNLC. Continue to read the Board of Nursing newsletter and look at the website for updates and the status of the eNLC.

This is an exciting time for nurses in Iowa and nationally as we continue to increase the mobility of nurses to meet the needs of patients and their access to care!

A Note From the Chairperson

As I write this article, summer has just started, and before we know it, it will be fall. I thought this was a good time to remind and update all licensed nurses on the role and responsibility of the Iowa Board of Nursing. The board is comprised of seven board members, consisting of two practicing registered nurses, one licensed practical nurse, two nurse educators, and two public members. Each board member is appointed by the Governor of Iowa and confirmed by the Iowa Senate for a three-year term, with a maximum term limit of 9 years. The board must be gender and political-party balanced.



The mission of the board is to protect the public health, safety and welfare by regulating the licensure of nurses, the practice of nurses, and nursing education and continuing education. The board meets four times

a year for three days and then has a monthly meeting via conference call that usually lasts several hours. The board agenda is posted on the Iowa Board of Nursing website and meetings are open to the public. Time is allowed on the agenda for public comment and anyone may speak for up to two minutes per person, or longer, if granted permission by the chairperson. The minutes of the Board of Nursing are also available on the website.

Iowa nurses are regulated by several chapters in the Code of Iowa, and the Iowa Administrative Code (IAC). The IAC rules are reviewed and updated on a regular rotation. The Board is proud to have had the "Enhanced" Nurse Licensure Compact approved by the Iowa Legislature in 2017, and the launch and implementation of the Iowa Nurse Assistance Program as a new resource for individual nurses who are impaired as a result of alcohol or drug use, dependency, addiction, or by any mental or physical condition.

It is each nurse's own responsibility to keep updated on all and any changes in nursing practice in Iowa. Be sure to visit the Iowa Board of Nursing website for updates and read the quarterly Iowa Board of Nursing newsletter. If you have questions, both resources provide nurses information about contact persons and phone numbers at the Iowa Board of Nursing.

Renewal Reminder

Licensees should plan to renew their nursing license 30 to 60 days prior the expiration date. A nursing license may be renewed until midnight of the expiration date without penalty, but this practice is discouraged. Online system problems can occur and late fees will be assessed for any renewal completed after midnight of the expiration date.

Expiration Date	Renewal Dates	Late Fee Assessed	Inactive Status (if not renewed)

A \$50 late fee is required for licensees who renew within the 30 days after the license lapses. Licenses that are not renewed will automatically be placed on inactive status on the 16th of the month following the expiration date of the license.

The continuing education requirement for license renewal is 36 contact hours (3.6 CEUs) for the renewal of a full three year license. Licensees renewing for the first time after the license was originally issued, or for the first time after a reactivation, will need 24 contact hours (2.4 CEUs) completed after the effective date printed on the license wallet card. Before you renew, you should have your documentation in-hand to confirm you have what you need. As soon as you renew, you will know if you have been chosen for audit. Remember, if it is not documented – it is not done!

Editor's note: At the time of this publication, proposed changes have been published for 655 IAC Chapter 5 rules regarding continuing education for Iowa's nurses. Watch the Board's website for updates.

INAP Update

Since the launch of the Iowa Nurse Assistance Program (INAP) in December 2016, the program has evolved and grown. INAP now has a fully functional INAP resource link on the Iowa Board of Nursing website. It can be accessed at <https://nursing.iowa.gov/iowa-nurse-assistance-program>. This link provides information about the program and has important forms including self-report, intake, participant tracking, and release of information forms. The INAP link also lists committee members, meeting dates, and contact information for the program. In the last newsletter, INAP addressed frequently asked questions and some additional ones are below:

1) What does it mean to “self-report” and are nurses required to do this?

Self-reporting is when the licensee provides written notification to INAP that the applicant or licensee has been or may be impaired. It initiates the process of reviewing an applicant or licensee’s impairment or potential impairment. All licensees seeking entry into INAP need to complete the self-report forms. These forms are available on the Iowa Board of Nursing website. Completing the self-report forms does not guarantee entry. INAP and all candidates must meet eligibility requirements.

2) Does INAP require drug screening and are nurses required to do this?

Drug testing is considered an essential part of this monitoring program for any nurse enrolled as a result of a substance use disorder and is a requirement of the program. All nurses with a diagnosed substance use disorder are required to participate in the testing process. Drug screening is a way to assure employers and treatment providers that nurses are maintaining their recovery. Nurses in the program are responsible for all costs associated with testing and expenses incurred to participate.

3) What is the INAP committee (INAPC) and what is their role?


INAP is managed by a committee who works with the program coordinator. The INAP committee consists of seven members including the director of the Iowa Board of Nursing, substance and mental health professionals, nurses recovering from addiction, and a public member. INAPC members bring an array of expertise and knowledge to the program. All licensees who have self-reported to INAP are reviewed by the INAPC for eligibility and committee members provide direction on cases. Committee meetings are conducted quarterly and the co-chairs serve as resources during non-meeting months.

What is the Iowa Nurse Assistance Program (INAP)?

INAP is a new resource for individual nurses who are impaired as a result of alcohol or drug use, dependency, addiction, or by any mental or physical condition.

It is a voluntary, confidential program and provides an opportunity for licensed professionals to receive proper treatment and maintain their professional status, while protecting the safety of the public.

Are programs like this successful?

Yes! Similar programs to INAP currently in practice show that an appropriate combination of treatment and support effectively help participants manage their impairment or condition.

Who may be eligible for the program?

- Nurses who voluntarily report themselves
- Nurses with any physical or mental condition affecting their practice
- Nurses who use alcohol or drugs to the extent their practice is affected

Referrals may come from:

- Self-referral
- Board referral
- Licensure department
- Enforcement
- Employer complaints

Impairment can cost your job and license.


INAP Serves Nurses:


- Consultation upon entering program
- Early intervention and treatment
- Referrals to local support services
- Ongoing monitoring and support as an effective alternative to discipline

INAP Serves the Public:

- Public protection through close monitoring to ensure safe practice
- Coordination with employers to assure patient safety and a smooth transition back to nursing practice

Who Runs INAP?

The Iowa Nurse Assistance Program (INAP) is authorized by the Iowa Board of Nursing to assist nurses in the early identification and treatment of impairment and illness. INAP is managed by a committee who works with the program coordinator. Committee members include the director of the Iowa Board of Nursing, substance and mental health professionals, nurses recovering from addiction, and a public member.

The INAP committee may:

- 1) Evaluate on a case by case basis whether candidates are appropriate for the program.
- 2) Submit recommendations to the Iowa Board of Nursing.
- 3) Monitor the recovery process of participants.

Fluoroscopy Audit Reminder

The administrative rules governing nursing in Iowa require Advanced Registered Nurse Practitioners (ARNPs) who supervise the use of fluoroscopic x-ray equipment to have the appropriate education and continued annual radiological safety updates. Pursuant to 7.2(d), the initial and annual education requirements are subject to audit by the Board. Therefore, the Board of Nursing will be auditing ARNP's who supervise fluoroscopy.

The initiation of the audit process began January 12, 2015. The process is as follows:

- On the ARNP online and paper renewal application a question will be asked if the practitioner provides direct supervision in the use of fluoroscopy. The renewal process is every three years,
- If the practitioner answers yes, they will be required to provide verification of completion of the initial course and yearly safety courses, along with a **copy of the course description and learning outcomes (it is important to submit the specific course description and learning outcomes and not just the course title),**
- Board staff will contact the practitioner if there are any questions about the submitted course work or if the practitioner has not completed their required education,
- At any point in time that board staff identifies the ARNP is not complying with the course requirements and the audit process the information will be submitted to the Enforcement Unit.

The Iowa Board of Nursing recognizes this is a new process for all ARNP's supervising the use of fluoroscopic x-ray equipment. Board staff is committed to assist practitioners in the audit process. 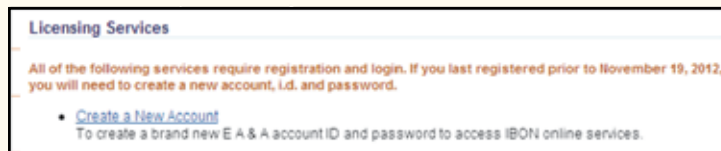

Creating an Online User Account

If you have ever done business online with any state agency (such as for college aid), you would use the same account id that you have already created. Otherwise, all license related processes begin with user registration, including updating contact, employment or educational information. Secured Access and ordering a roster also require the visitor to register.

The main menu displays the following option:



If you click on "Create a New Account," you will be taken directly to the registration page and tab that you need in order to register:



This registration site is maintained by the state's technology division as a global login for the entire state enterprise.

Enter your first and last name:



The registration automatically combines first and last names into a suggested user i.d., and appends "@iowaid." But if the first name/last name combination already exists, the i.d. field will appear blank, and you will need to create your own account i.d. In either case, anything can be substituted ahead of the "@", but the i.d. that is created is permanent so it will need to be memorable.



Enter your email address twice in the screen pictured above, and click "Save Account Details." A popup box gives a final caution.



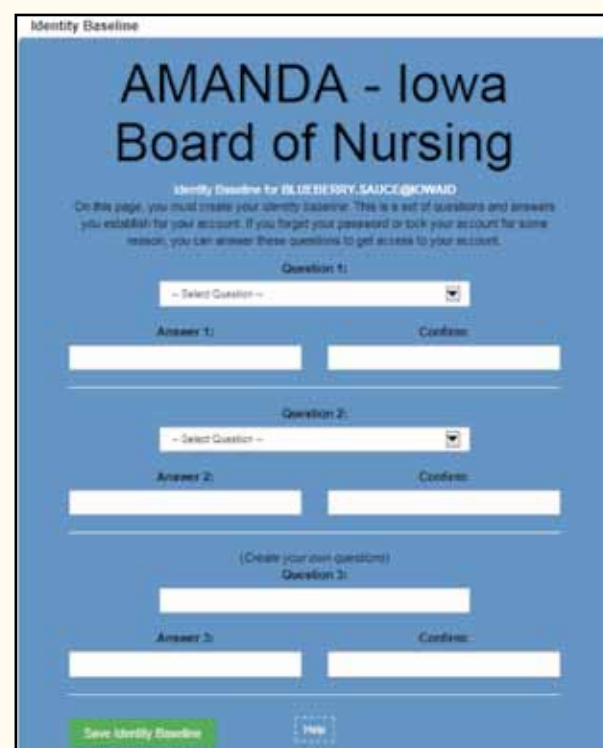
If you created an i.d. with your first.name.lastname as your i.d., and someone else with the same first and last name has already registered to do any kind of business with the State of Iowa, you will receive the following error message.



After successfully selecting an i.d., entering the email address twice and clicking "continue," you will see the following screen advising you that an email has been sent with information to complete the registration. Note that there is a time limit of 48 hours to complete the registration.



The email will include a link to come back to the registration site. This is done as verification that the email address is a real one. Clicking the link in the email returns the user to the following screen at the EAA website to complete the registration by selecting security questions and answers.



The next screen requires the user to create their password:



The registration is complete, and the user is taken to the screen where they can actually log in. Note that the above registration process should only be required once. Thereafter, the licensee would use the existing account.

Also note that on most screens there is a "Help" button. This will take you to a help library maintained by the state's Office of the Chief Information Officer (OCIO), and may take you to the relevant portion of an extended FAQ system.

It is only on the login screen itself, that you will find a link to report an issue to the OCIO Help Desk.



This link will take you into the state's OCIO site to submit a service request or inquiry.

APRN Compact Moving Forward

Currently, Iowa does not recognize the title “Advanced Practice Registered Nurse” (APRN), but for accuracy concerning the APRN Compact, the title APRN will be used throughout this article.

In 2002, the first APRN Compact was adopted by three states: Texas, Utah and Iowa. However, this version of the APRN Compact was not implemented – partially due to the lack of uniformity of APRN licensure requirements between states. Following the adoption of the National Council of State Boards of Nursing’s (NCSBN) APRN Consensus Model in 2008, the three compact states identified an opportunity to address the lack of uniformity and create a new version of the compact which incorporated the APRN Consensus Model. The APRN Consensus Model provides clarity and uniformity for the APRN role, population foci, specialty areas, scope of practice and educational requirements.

In 2011, the APRN Compact Work Group formed and drafted the new APRN Compact. The APRN Compact was approved by the NCSBN membership in May of 2015.

The following statements are common to both the “Enhanced” Nurse Licensure (eNLC) Compact and the APRN Compact:

1. Uniform licensure requirements (ULRs) for all states, as defined in statute for the eNLC and defined in rule for the APRN compact.
2. The practice of nursing takes place in the state where the patient resides.
3. Nurses have the ability to practice in multiple states with one license.
4. The Compact will:
 - a. Reduce regulatory requirements by eliminating the necessity to obtain a license in each state.
 - b. Increase access to care while maintaining public protection.
 - c. Clarify a nurse’s authority to practice in multiple states via telehealth.
 - d. Allow nurses to quickly cross state borders and provide vital services in the event of a disaster.
 - e. Remove burdensome expenses for both nurses and the organizations that employ them.
 - f. Provide member states the authority to facilitate a discipline case across state lines.

The general provisions specific to the APRN Compact as summarized by the NCSBN, are listed below:

1. A member state must implement procedures for considering the state and federal criminal history records of applicants for initial APRN licensure or APRN licensure by endorsement.
2. The APRN Uniform Licensure Requirements (ULRs) adopted by the Commission provide the minimum requirements for APRN multistate licensure.
3. To obtain/retain a multistate license, an APRN must meet the home state’s qualifications, in addition to the ULRs.
4. The Commission identifies in rule the approved APRN role and population foci for licensure. An APRN shall be licensed in an approved APRN role and at least one approved population focus.

5. An APRN multistate license is recognized as authorizing the APRN to practice in each party state under a multistate license privilege, in the same role and population focus as in the home state.
6. An APRN multistate license shall include prescriptive authority for non-controlled prescription drugs. An APRN shall satisfy all requirements imposed by the state for each state in which an APRN seeks authority to prescribe controlled substances.
7. An APRN multistate license holder is authorized to practice independent of a supervisory or collaborative relationship with a physician.
8. Authority to take adverse action against a multistate licensure privilege with application of state due process laws.
9. Nurse compliance with state practice laws.

To clarify the “Interstate Commission” is the governing body of the APRN Compact. This term is commonly used by other Interstate Compact governing bodies. The Commission will have the authority for rulemaking. The rules will specifically outline the ULRs and address the key components of the Consensus Model.

The following are key components to remember as Iowa moves forward with the APRN Compact:

1. The APRN compact is an interstate compact which is a statutory agreement between two or more states. It is comparable to the National Driver’s License Compact, which allows you to have one license and drive in other states following the rules and regulation of that state.
2. The APRN compact will allow an advanced practice nurse to be issued a multistate license in their home state with the privilege to practice in other Compact states.
3. The multistate license only allows the advanced practice nurse to practice in states which are members of the Compact. A single state license is necessary for an advanced practice nurse to practice in non-compact states.
4. The APRN Compact, written in statute, does allow for the independent practice of an advanced practice nurse. **Advanced Practice Nurses in Iowa have had independent practice for over 20 years.**
5. The APRN Compact, written in statute, does allow for independent prescribing of non-controlled prescription drugs by advanced practice nurses. **Advanced Practice Nurses in Iowa have had prescriptive authority of non-controlled substances for over 20 years.**
6. The APRN Compact language is about a multistate license which allows for portability and mobility of nurses. It promotes telehealth, which is an emerging method of accessing health care, especially for patients with mental health needs.

The APRN Compact was introduced in the 2017 Iowa Legislative Session, but did not move forward. The

only opposition voiced concerning the APRN Compact was from the Iowa Society of Anesthesiologists. The Iowa Society of Anesthesiologists contend that the APRN Compact’s language deals with scope of practice issues. Please note, **the scope of practice is not changing for Iowa advanced practice nurses by becoming a member of the APRN Compact.**

As we move forward with proposed legislation for Iowa’s 2018 legislative session, please become educated about the APRN Compact and talk to your legislators. To adopt the APRN Compact all advanced registered nurses need to be supportive of the compact and advocate for its passage.

The APRN Compact will be implemented once 10 states have adopted the Compact. Idaho, Wyoming and North Dakota have adopted the APRN Compact.

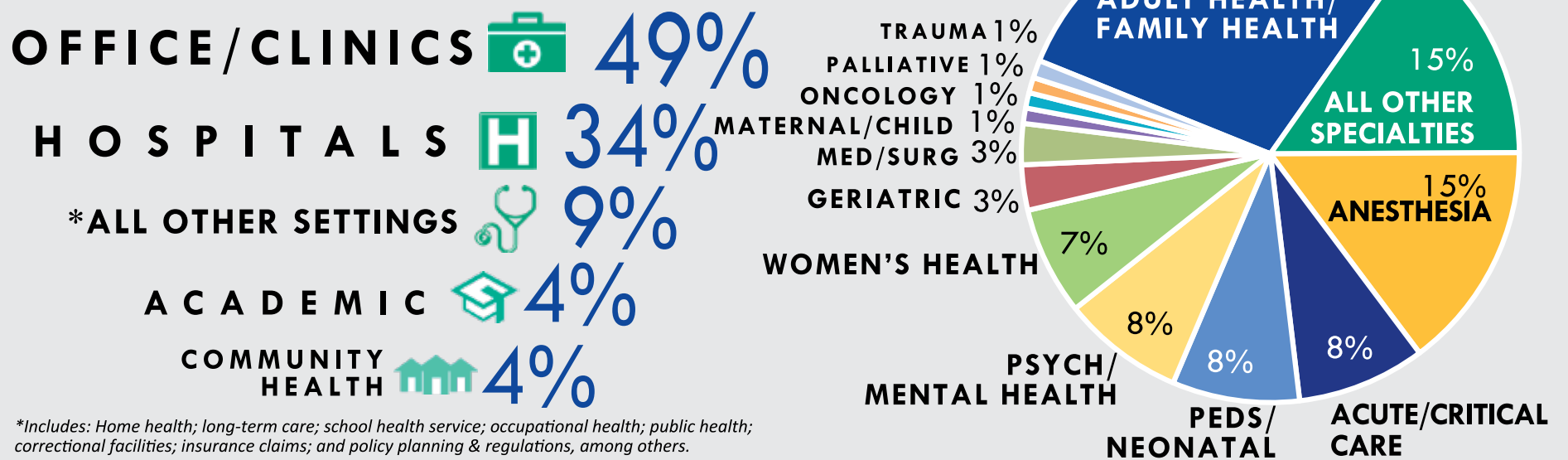

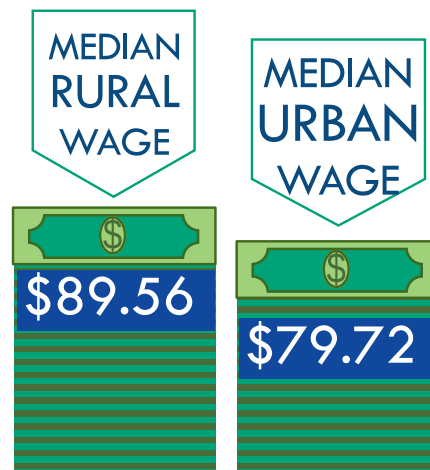

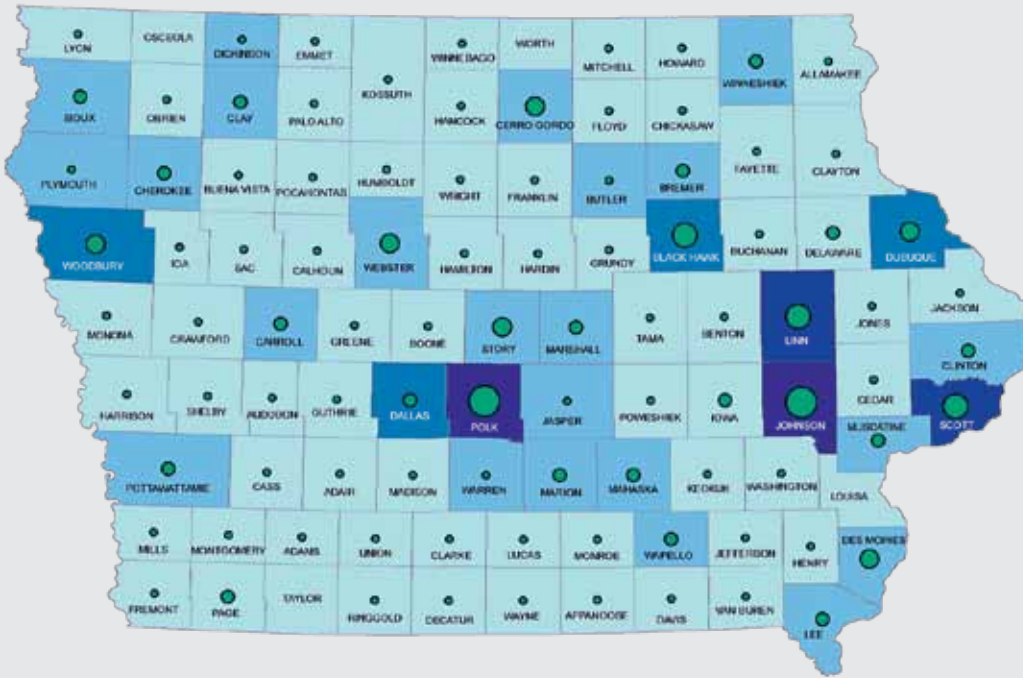

COUNTY OF RESIDENCE

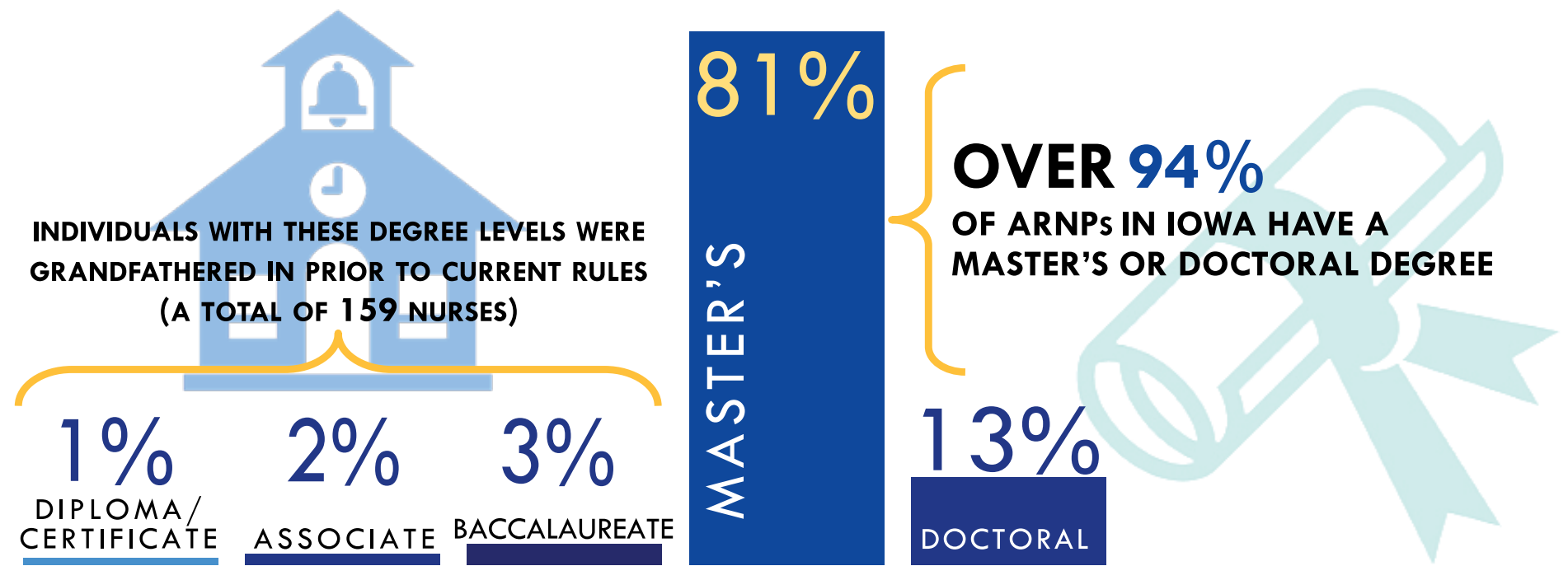

Through their BSN and graduate education, Advanced Registered Nurse Practitioners (ARNPs) are prepared to provide safe, effective and quality care to the public. The Institute of Medicine report that examined decades of research on ARNP practice—The Future of Nursing: Leading Change, Advancing Health—recommended that states remove barriers to full scope of practice for advanced practice nurses (IOM, 2011). The National Governor's Association (NGA) conducted a comprehensive review of the literature to determine the effect of scope of practice changes on health care access and quality. The results of the NGA review confirmed that ARNPs provide high quality care and evidence that ARNPs can improve access to care (Schiff, 2012; Sox, 1979). Furthermore, the VA Evidence-based Synthesis Program depicted similar results on health outcomes and quality of life among the four ARNP roles (McCleery et al., 2014).

What is the Nurses on Boards Coalition?

Nurses represent the largest segment of health care workforce, and are considered the most trustworthy of all professions' and play a huge role on the frontlines of care in our schools, hospitals, community health centers, long-term care facilities and other places. Their perspective and influence must be felt more at the decision-making tables.

The Coalition's guiding principle is that building healthier communities in America requires the involvement of more



nurses on corporate, health-related, and other boards, panels, and commissions.

TO CHANGE YOUR EMAIL ADDRESS

If your email address changes, it needs to be updated in two different places: your IBON record, and your login account. These are hosted separately.

To update your IBON record:

Although you can wait until you renew your license, it may be wiser to update it immediately, as follows:

1. Go to IBON Online Services and select "Update Contact Information."
2. This will take you to the Enterprise login screen mandated by the State of Iowa.
3. Enter your account i.d. and password, and click "Sign In."
4. You will be returned to the Iowa Board of Nursing Online Services, and the proper screen to update your information.
5. Update all available fields on the screen – including your email address, and click Continue.

To Update your login i.d.

Your login email is different from the email address in your license record. The login email is used by the state's mandated authentication services for all state business. If you forget your login i.d., the system can send it to you – but it will go to the email address they have on record in the login account, not to the address in your license record.

1. Go to IBON Online Services and select "Update Contact Information." This will take you to the Enterprise login screen mandated by the State of Iowa.
2. On the login screen (below), enter your account i.d. and password, **BUT instead of clicking on "Sign In," click on "Account Details."**



3. This will take you to the following screen, where it is apparent that you need to enter your new email twice and click save.



Additional note:

If you can remember neither your login i.d. nor your password, AND your email address has changed, you have two choices:

1. Create a new and different login i.d. and password. The new login i.d. must be different from the one you initially created, i.e., Suzy.Smith@iowaid could become Suzy.Smith2@iowaid.
2. You can request assistance through the state's Help Desk from the links available in the lower right of the login screen, or by calling 515-281-5703, or 1-800-532-1174.

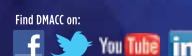
